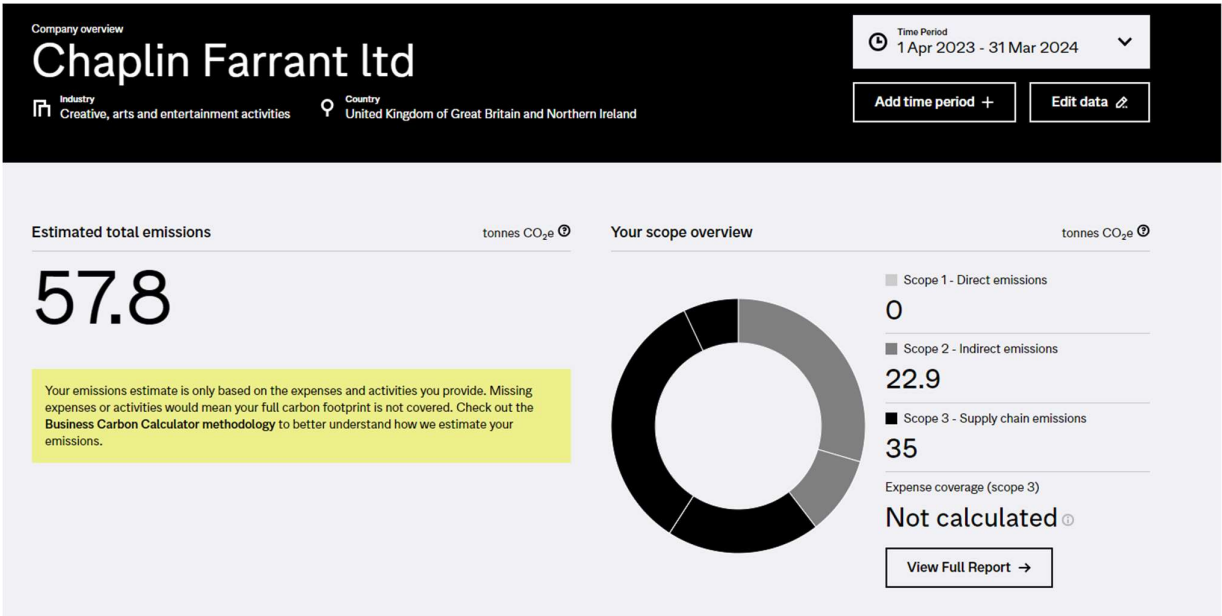

Completed Carbon Reduction Initiatives

In 2023 we undertook a detailed assessment of Chaplin Farrant and opportunities to reduce our carbon footprint. We current hold ISO14001 certification which provides additional environmental guidance to formulate our wider net zero plan.

We will have a task group to review these opportunities 6 monthly to measure progress. Within the next 12 months Chaplin Farrant will develop a detailed sustainability strategy aligned to our business that helps us to achieve net zero as soon as possible. Progress will be monitored in Senior management meetings and Jerene Irwin & Martin Lewis will have overall responsibility for the plan and its development.

First year targets include:

1. Develop sustainability policy for the business
2. Develop a travel policy that aligns to our net zero objectives
3. Review and reduce the energy usage within our office locations
4. Review credentials of our suppliers and aligning to our strategies
5. Review waste collections / recycling generally
6. Develop our marketing strategy to support the growth of sustainable projects
7. Develop a specification policy that aligns to our net zero ambitions
8. Review the source of our energy supplies – aiming to switch to a renewable source
